



Touma Terms and Conditions of Use

Effective Date: January 27, 2026

These Conditions of Use ("Conditions of Use") apply to the Toastmasters Shanghai Education Technology Co., Ltd. (头马识途 (上海) 教育科技有限公司) ("Touma" or "Toastmasters Shanghai") located at <https://www.toastmasters.cn/> (the "Site").
